

The primary objectives of the Association are to:

- be a central representative body to put the views of members to Government departments and agencies, Parliament, the European Commission and other relevant organisations
- be a research and statistical centre providing commentary, guidance and advice on all regulatory matters and developments of relevance to the amusement and leisure industries
- provide a forum for the exchange of non-competitive information
- have representation on all national, or, if appropriate international safety Committees
- promote the amusement and leisure industry through conferences, seminars and other means
- act as sponsor for members who wish to take advantage of funding provided by the UKTi for participation in exhibitions or trade missions in overseas countries and to carry out all tasks relative to such applications
- liaise and work together with complementary industry organisations where there is a perceived mutual benefit to members

Membership Criteria

Only companies who are registered at Companies House or are otherwise registered to trade as a United Kingdom company or organisation are permitted to be considered for membership.

FULL membership is available to corporate manufacturers and suppliers of all kinds of non-gambling amusement and leisure equipment, or providers of services directly related to the non-gambling amusement and leisure industries.

MEMBERSHIP FEE - £200 per annum.

ASSOCIATE membership is available to any corporation or individual whose activities otherwise have a direct interest within the non-gambling amusement and leisure industry.

MEMBERSHIP FEE - £100 per annum.

Applications for membership must be submitted on the relevant form and must be accompanied by the appropriate membership fee.

A Certificate of Membership will be issued on acceptance of the application by the Management Committee.

The Association's financial year is from 01 February to 31 January but membership is valid for 12 months from the date of confirmation of application.
